Sir,

Pension matters

I retired from the Reserve Bank of India, Trivandrum, in 1996 as Asst. Manager, and have been drawing pension under the RBI pension Regulations, 1990.

2. At the time of the introduction of the Pension scheme in the Bank, it brought to the notice of all employees the contents of its circular PPD No.G.66/2180/RBI.C.P.17ID-91/92 making a commitment to them on
 - i) Updating of basic pension on the pattern applicable to Central government pensioners
 - ii) Fairness in regard to computation of dearness relief, and
 - iii) Social security through the pension scheme
3. (1) The Bank effected wage revision in the case of its employees with effect from 1.11.02 long ago and even the next revision would fall due in another six months.
- ii) The Bank has done away with the tapering pattern of neutralization of dearness allowance in the case of all its employees and that of dearness relief to pensioners in the case of post-November 02 retirees effective from 1 February 2005.
4. Despite the lapse of about 2 years, the Bank has not done updating of basic pension and extension of the benefit of 100% neutralization in dearness relief to pensioners in the case of pre-November 02 retirees contrary to the written commitment indicated in paragrapg 2(i) and (ii)above.
5. The Bank has not, despite the lapse of several years,effective any beneficial revision in the case of family pension in tune with the social security concept referred to at item 2(iii)above.
6. I understand that ordinarily agitating matters of the above type in a court of law would be possible only after a final adverse decision is taken and conveyrd by the authority. As,however, more than sufficient time has been available to the Bank for taking final decision in these matters, a plea that the issues are still under the consideration of the management would be of no avail and could be construed only as a time-buying ruse,unjustifiable on all counts.
7. I, therefore,hereby give you notice that in case your final decisions in the matters raised herein are not communicated to me within 30 days from the date of receipt of this letter by you,it will be presumed that the Bank's stand is adverse to my interests. please also take notice that such a ground would be taken by me in legal proceedings that may be launched after the time limit indicated.

Pension Matters

Please refer to your letter dated May 22,2007 on the captioned subject.

In this connection, the issues raised by you and our comments thereon are given as under:

- (i) Updating of basic pension on the pattern applicable to Central Government pensioners

Our Comments: In view of numerous representations from the pensioners to update their pension as done by the Government to their employees and to have uniform Dearness Relief formula for all pensioners so as to minimize the administrative inconvenience, the updatation of pension was carried out by the Bank in September 2003 for pre-November 1997 retirees'. However, the Government of India had, vide their letter dated August 08,2005 advised the Bank that the updatation of pension based on the revised scale of pay should be withdrawn. The matter is still however being pursued with the Government.

- (ii) 100% neutralization of Dearness Relief to all pensioners

Our Comments: Dearness Relief to the pensioners who retired prior to November 01,2002 is being calculated on tapering basis on four tiers with neutralization at 100%,83.3%,50% and 25% based on the All India CPI=1684. In this regard it may be stated that the proposal to grant extension of 100% neutralization in Dearness Relief to pre-November 2002 retirees is under examination of the Bank.

- (iii) Social security through the pension scheme-Revision of family pension

Our Comments: As is required for amending statutory regulations, the Bank had sought prior approval of the Government to amend the RBI pension Regulations,1990 for family pension @ 30% to the spouses/ eligible family members of employees who were in sevice on November 01,1997 or died in harness or died after retirement thereafter. However, the Government did not accept the proposal. This issue is under corresponce with the Government of India.

It is further advised that the position of the Bank in the matters referred above has been clarified. However, in case you choose to launch legal proceeding against the Bank, the Bank shall be constrained to defend itself, at your cost.
