Representation mandated by the Bombay High Court vide Order dated 27.04.2009 in Writ Petition No.710/2009 against withdrawal of updation of pension by Reserve Bank of India – Meeting with the officials of Ministry of Finance – Gist of Proceedings

- (i) The contribution by the Bank to the Pension Fund during last 10 years
- (ii) Copy of the Memorandum submitted to the Committee of the Central Board in 2003 and their resolution for updation of pension
- (iii) Copy of Memorandum submitted to the Central Board in August 2008 and resolution of the Board which led to the withdrawal of updation

He also wanted to know the level at which the Circular dated October 10, 2005 withdrawing the updation of pension was approved and whether legal advice was taken while drafting the circular. He further enquired about the level at which the Bank's counter affidavit in the Writ Petition 710 of 2009 was approved.

4. Government was assured that the required information will be submitted to them very shortly. On the issue of contribution to Gratuity and Superannuation Fund, CGM clarified that the Bank's contribution is made on the basis of actuarial valuation of future liabilities of the Bank on account of pension, Gratuity and such other payments. He said that the income of the Bank is appropriated towards the various funds and reserves as per the directions of the Central Board of Directors who are vested with the powers to do so and the surplus is transferred to the Government. CGM also stated that the issue of pension updation is not limited to the employees affected by the court case under reference but also to the present employees and has become a very serious IR issue. He said that while introducing the Pension Scheme in the Bank, the employees were advised that the regulations were modeled on the CCS Pension Rules. It was also promised by the Bank in 1992 by issue of a circular that updation would be a regular feature of the Scheme. He requested the Government to ensure to find out an appropriate solution for the issue saving both the Government and the Bank from embarrassment keeping in view the likely legal issues that might arise because of the proceedings in the High Court. He also invited attention of the Government officials about the IR implications of the matter in the Bank.

HIT GUJ P.R.R. Nayar Questions

The valiant fighter from Thiruvananthapuram for RBI retirees, Shri P.R.R. Nayar, has sought for pertinent information from Reserve Bank under the Right to Information Act, 2005 arising out of the unsavoury observations made by the Ministry of Finance officials in the speaking order. Among other things, he has asked from the Bank a copy of the note recorded on the deliberations the Bank officials had with the Ministry of Finance on 14-7-2009, details of follow-up action and Bank's responses to the contents of certain paragraphs of the speaking order, such as Nos. 4.5 (The Board is not entitled to assume, usurp and exercise such powers which are not vested with it) and 4.22 (RBI has made excessive contribution to superannuation fund resulting in bloating of the fund which should not be used to shower undue benefit to anyone).

Shri Nayar has also written to the Ministry of Finance drawing their attention to the statement of Shri Virappa Moily, Union Law Minister, that a litigation policy is being framed by the Central Government by which the Central is aiming to be transformed from a compulsive litigant to a responsible and reluctant litigant. Shri Moily had observed that the Centre was the biggest litigant in the country. In the light of this, Shri Nayar has asked Moily not to pursue its case against upgradation of pension to RBS retirees.
