### PENSION UPDATION

There has been no further development in the matter of pension updation since the issue of our bulletin in August last. As members are aware, there were some positive developments—last year and in the first half of this year too, as the Bank had been actively pursuing the matter with the Central Government with a proposal to amend the Pension Regulations to provide explicitly for updation of pension by the Bank. Suddenly, all activities have now come to a stand still. Even in respect of certain improvements in the family pension and pension scheme reportedly cleared by the Government, the Bank has not yet issued administrative orders implementing the same, for unknown reasons.

#### WRIT PETITION ON UPDATION

The Division Bench of Bombay High Court, in its orders dated 10th August 2012, had asked the Bank for its views on the contention of our Sr Counsel Rafique Dada that it would be necessary for the Bank to hear the petitioners before taking any action for withdrawal of updation given by it to the pre- November 1997 pensioners to avoid unnecessary litigation. The Bank, in this context, filed an affidavit on 11-9-2012 raising mainly two issues:

(1) Due process of hearing the petitioners has already been concluded with Government passing a speaking order dated 23rd October 2009 and that the principle of natural justice requiring a hearing to be given before taking an adverse action has already been followed and (2) The Bank has forwarded a proposal to the Government seeking their approval to amend the Pension Regulations to provide explicitly for updation of pension by the Bank which is under the consideration of the Government.

The All India Association filed a rejoinder dated 4th October 2012, as under:

- (1)In its speaking order, the Government categorically stated that it was not passing any order or giving any direction to the Reserve Bank in the matter
- (2) If the RBI Pension Regulations are amended as proposed by the Bank, it would explicitly provide for updation of pension in the said Regulations but at the same time it would not distract from the fact that updation can be effected without such an explicit amendment. Throughout its communication with the Government including through resolutions passed by the Central Board of the Bank, and its affidavit filed earlier in the Writ Petition, the Bank had consistently taken a stand that updation of pension was effected within the purview of its Pension Regulations and that no amendment was required for the same. In the aforesaid circumstances, it was prayed that the petition deserved to be allowed on merit.

The hearing scheduled for 29th October 2012 did not come up that day. The next date is yet to be notified by the Court.

## Thiruvananthapuram Unit of Retired Employees' Association

The Thiruvananthapuram unit has sent a letter dated 18th September 2012 to All India Association (with a copy to other units) requesting them to seriously consider seeking the intervention of the Supreme Court by filing a writ petition, for getting the updation issue resolved. They have suggested that the cost of legal expenses for the purpose could be collectively borne by all units.

The Managing Committee of our unit at its meeting held on 26th November 2012 deliberated, among others, the points /issues raised in the Thiruvananthapuram unit's letter and decided to fully support their views and to convey the same to the All India through a suitable letter. Accordingly, Kochi unit too sent a communication to the All India Association requesting them to arrange to examine the feasibility of filing a writ petition in the Supreme Court, without awaiting the final outcome of the ongoing case against the roll-back of pension updation, in the Bombay High Court.

The Managing Committee has also decided to consult an Advocate of repute to get his opinion as to whether it is feasible for our unit (being a registered body) to file a special leave petition directly in the Supreme Court.
